

## GCSA News Bulletin – February 2014

#### 1. EPA's 2014 MS4 Stormwater Conference in Fort Worth, Texas

**INCOG NOTE:** For those of you who are new to GCSA, this annual EPA Region 6 stormwater MS4 conference is considered the best of all 10 EPA regions. It brings together permittees with professionals in stormwater services, program management and permit compliance. There are many opportunities to view the latest products and services and network with others who share similar problems and strategies. Dates for next year's conference are July 27 to August 1, 2014. The Northwest Arkansas venue is probably certain, but it has not yet been announced as a final decision. Conference organizers are actively reviewing all presentation abstracts, so the first detailed agenda will be available shortly. Registration will be around \$300 - \$350, with an Early Bird discount. As usual, there will be pre-conference certification training classes starting Sunday, with Monday devoted to the certification testing and "Stormwater 101" sessions for those new to the permit program.



## 2. LID Design Competition and Research Symposium Update

**INCOG NOTE:** The Tulsa area LID Design Competition is well underway. Design Teams have been formed, and final designs are due the first part of March to start technical evaluation. The April 3<sup>rd</sup> **Great Plains Low Impact Development Research and Innovation Symposium** will have brief oral presentations by all contestants, with the three winners announced that evening. There are \$10,000 cash prizes for the winners of each of the three design categories.

GCSA Members are encouraged to attend the Symposium. This is a unique opportunity to have LID heavily promoted in our area, learn about the latest LID innovations from speakers representing 10 states, and meet the BMP for employee training. Why is the LID Design Competition Important to GCSA? There will be new requirements in the revised OKR04 for permittees to do education and outreach about LID to builders, developers and the community at large. This LID event encompasses general awareness about LID, provides detailed project development specification data about area projects, will likely lead to actual installation of LID in at least one of the projects in the near future, and will provide data that compares LID cost savings and benefits over standard development designs that lack LID. The LID Symposium will attract parties of interest from many regional states to see how LID is growing and benefiting the Tulsa area.

#### 3. Missouri Supreme Court Rules Against St Louis Stormwater Fee (repeat)

## Courts Strike Down Stormwater Fees

In mid-November, the Missouri Supreme Court ruled that the St. Louis Metropolitan Sewer District (MSD) stormwater fee is actually a tax, which violates the state's constitution because it was established without voter approval.

The <u>court opinion states</u>, "A tax by any other name remains a tax. It cannot be transformed into a user fee by adept packaging any more than a zoologist can transform a horse into a zebra with a bucket of paint. Here, no matter how many stripes MSD paints on it, the stormwater user charge is not a user fee."

The stormwater fee, based on impervious surface area and established in 2008, was intended to help the sewer district raise nearly \$60 million per year to address stormwater budget shortfalls.





There have been a number of court cases on stormwater fees in recent years. In another case, decided in September, an Ohio appeals court struck down the Northeast Ohio Regional Sewer District's stormwater fee, ruling that the sewer district did not have the authority to enact a regional stormwater management program or fee. The Northeast Ohio Regional Sewer District is currently obligated to a \$3 billion combined sewer overflow (CSO) long-term control plan, Project Clean Lake. The decision hinders the ability of wastewater utilities to address CSOs and is impactful because it could serve as a legal precedent outside of Ohio.

The National Association of Clean Water Agencies (NACWA) and the Association of Ohio Metropolitan Wastewater Agencies <u>filed an amicus brief</u> in the Ohio Supreme Court to appeal the ruling.

### 4. Idaho Supreme Court Rules Against Lewiston Stormwater Fee (repeat)

### Idaho Supreme Court Rules Stormwater Fee Unconstitutional

In early November, the Idaho Supreme Court ruled the city of Lewiston's stormwater fee unconstitutional because it qualified as a hidden tax, as it was not previously authorized by the Idaho legislature. The fee — levied in 2008 — was based on impervious surface area. However in 2009, a local state college, port, school district, irrigation district, and Nez Perce County <u>filed a lawsuit</u> against Lewiston. In Idaho, local governments cannot tax one another, so by classifying the stormwater fee as a tax, the plaintiffs would not have to pay.

The ruling was made in part because the Idaho Supreme Court classified the fee as revenuegenerating and because the city charged property owners regardless of whether they used the stormwater system.

## 5. Results of INCOG's Quick GCSA Survey on Stormwater Fee Exemptions

**INCOG NOTE:** INCOG recently became aware of a city council meeting in Oklahoma in which the local stormwater fee was being challenged by a few businesses. The issue revolved around exemptions granted in the fee ordinance for a certain type of right-of-way (ROW). When the city tried to correct the exemption issue, a state legislator who was present and other citizens said that they would seek an Oklahoma Attorney General opinion on the local fee.





In order to update the status of local fees being used by GCSA members and exemptions they may have, INCOG conducted a quick poll of its GCSA members on whether or not they had a local stormwater fee, and if so was there a different assessment for non-residential properties, and did the city have any exemptions for ROWs or other land use characteristics (e.g., open spaces, public buildings, etc.). The overall results are summarized in the table below:

Four GCSA members are counties (Tulsa, Wagoner and Rogers, with Creek being a co-permittee with Sapulpa), so they did not respond because counties do not have monthly utility billing systems. Of the 20 cities polled (18 GCSA cities plus Collinsville and Tulsa), 19 responded to date, with 16 having stormwater fees, and 13 having separate fees for non-residential properties. Twelve offer some forms of exemptions (numbered in the summary table above).



## 6. INCOG Full Survey of Stormwater Fees for GCSA and Statewide

After discussing with its GCSA members the need for an updated comprehensive fee survey, INCOG is preparing to perform a comprehensive stormwater fee survey this summer of its GCSA members, and to solicit input from other MS4 permittees statewide. It was decided in our last GCSA Meeting that a GCSA-focused survey would be more important to local management than a statewide survey, but that having statewide data would also be beneficial. INCOG will therefore assemble a comprehensive questionnaire in late Spring and Summer and submit it to its GCSA members. INCOG will also send the survey to Central Oklahoma Stormwater Alliance





(COSWA) management for non-GCSA survey participation. A final survey report will be prepared by late summer or early fall.

This item illustrates the types of regional public information that can be generated / purchased for our GCSA area if desired. Several members of COSWA pool funds to purchase radio advertisement time for stormwater spots. INCOG has resources to develop our Ozone Alert! public outreach campaigns, and we could probably enlist their aid in developing a regional stormwater public outreach campaign as well. The main cost is in the purchase of media "air time" which can be expensive. We raise this issue annually just to be certain that GCSA members know of the options.

## 8. EPA Region 6 Quality Assurance Training Possible for a Few GCSA Members

**INCOG NOTE:** The following was copied from an email announcing the May 6-8, 2014 EPA training dates on Quality Assurance. This is the formal QA training that is required for those entities that collect and/or use water quality data under EPA water quality funding. While this does not include any GCSA member, the host organization for this year's training, the Office of Secretary of Environment (OSE), has received approval from EPA to accept a few GCSA and other non-agency staff into the training if there are any seats available. Obviously the grant recipient entities have priority. INCOG will follow the class enrollment of this course, and if there will be any free seats available, GCSA members will be notified. Here is the OSE email announcement:

EPA Region 6 will be holding a QA/QC training in Oklahoma City May 6-8, 2014. The training will take place at the Oklahoma Department of Environmental Quality, 707 North Robinson in the 2<sup>nd</sup> Floor Training Room. Please see the attached announcement for details regarding the training.

There are 20 spaces reserved for State agency personnel. Because space is so limited, preference will be given to first-time attendees involved in the design or oversight of environmental data collection activities. Please complete the information on the attached spreadsheet for those from your agency needing this training and return the list to me. #### **Roadblocks to Low Impact Development**

In 2008, the Center for Watershed Protection surveyed 73 communities to better understand how these communities practice watershed planning, and to identify barriers to implementing LID and other comprehensive watershed planning efforts. And while many communities did express the physical characteristics of their geography as barriers to implementation, the greater stumbling blocks were those common throughout the United States: *a lack of good local examples and local codes that restrict innovative development practices*. This workshop will help us identify local codes and policies that restrict low impact development practices and identify alternatives that have been implemented in other communities.
